Special Instructions to all the Principals of Affiliated Colleges
(UG- II- Semester Examinations of July - 2026)

- The College Principals have to open their corresponding User IDs with their Passwords provided by M/s Tata Consultancy Service (TCS), Mumbai and upload the particulars of the Students through <https://www.tcsion.com/SelfServices/> for any queries send to email ajay.basampelli@tcs.com & helpdesk.svuexams@gmail.com.
- The online applications have to be filled by the respective colleges through their college logins and submit the same on the above website. While uploading, If there is any technical problem arisen that has to be brought to the notice of the undersigned immediately for rectification.
- The College login will be closed after the last date as mentioned in the notification.
- Principals are requested not to forward/ submit the examination application forms of not eligible candidates. The results of Not- Eligible candidates will be cancelled at any stage, if they appeared for the examinations and penalty will be levied both on college and students.
- The Principals are requested to pay the examinations fee collected from the Students through online only and submit the hard copy of applications and nominal rolls to the undersigned immediately. Otherwise, the Hall- Tickets will not be issued, so as to avoid the future problems at the time of publishing the results.
- Principals are requested to verify all the applications carefully and upload only eligible candidates.
- Principals are responsible for all the uploaded applications from their respective college login.
- The maximum period for supplementary candidates is fixed as 3 years from the completion of course period after which he/ she will not be allowed to appear for the examinations.
- The students, who have admitted during the academic years 2015-16, 2016-17, 2017-18, 2018-19 and 2019-20, are not eligible for the above examinations.
- The students, who have admitted during the academic years 2020-21, 2021-22 and 2022-23, shall write the examinations as per the 2020 Regulations.
- The students, who have admitted during the years 2023-24 and 2024- 25 shall write the examinations as per the 2023 Regulations.
- The students, who have admitted during the year 2025-26, shall write the examinations as per the 2025 Regulations.
- No offline Examination applications will be entertained in the office of the Controller of Examinations.
- Further, the Principals are requested to submit the downloaded applications along with remittance receipt through special messenger on or before the last date fixed by the University. If the college concerned does not submit the filled- in applications along with fee remittance receipt to the University within the prescribed date, even though the students have paid the fee in time, the Principals concerned are responsible for the late submission of applications and penal fee will be collected from the Principals concerned.
- Time – Table will be circulated in due course.
- A copy of the fee structure is enclosed herewith (Appendix- I). The Principals are requested to display the same on the notice board of the college.
- The Principals are requested to send the Nominal rolls (course wise, group wise and medium wise) separately in the prescribed proforma.
- The Principals are requested to cooperate in sending the examination applications in time to the undersigned.
- Practical Examinations of the above semesters shall be conducted and completed by the concerned colleges before the commencement of the examinations.
- The Principals are requested to send the marks immediately, after completion of the practical examinations through the e- mail ID svuinternals@outlook.com as per the format and submit the same (hard copy) to the undersigned.
