Sub: S V University – Conduct of Pre- Ph.D.(Written) Examinations of 2021 – Request for sending of the Syllabus, Model Question Papers & Panel of Paper Setters Examiners – Reg.

With reference to the above, I am by direction to inform that, Full-Time/Part-Time Pre-Ph.D. (Written) Examinations of 2021 will be held during the year 2022. The students who were admitted during 2019 and 2020 and who have completed one year as Full-Time scholar i.e., upto as on date of issue of circular and Two Years (two summers) as Part-Time scholar i.e. upto 2021, are eligible to appear for the said examination.

The candidates are required to pass the above course; the minimum marks required for pass shall be 55% (as per the Ph.D Regulations 2019) and 50% for the candidates joined earlier. In case a candidate fails to pass in three attempts (attempt means appearance) and within 4 year from the date of registration, the admission shall be cancelled and as per UGC Guidelines, Research and Publication Ethics (R&E) 30 hours is compulsory. (as per the Ph.D Regulation 2019 in SL.No.2.2 and 2.4 at page No. 09 and 10).

Further, the students who were provisionally admitted into Ph.D course through DST INSPIRE / MANF/RGNF/TEQUIP are eligible subject to qualify SVU RESET / GATE / UGCNET/ CSIR NET / APRCET any UGC accredited exams within a period of two years from the date of Registration only.

I am, therefore, request you to circulate the above information among the Staff Members (i.e. Research Supervisors, Chairman BOS) and students and send the details on or before:31.12.2021 in the enclosed Proforma. Failure to furnish full particulars may result in denial of a chance to the eligible candidates from appearing for 2021 examinations. A copy of the same may be displayed on the Notice Boards.

The panel of paper setters/examiners for Paper-I (Research Methodology) shall be furnished by the Chairman, BOS of the concerned Subject (in 3 sets), as early as possible (preferably on or before:31.12.2021).

- The Research Supervisors of the candidates concerned shall furnish
- Four typed copies of syllabus in the prescribed Proforma, and need not mention the name of the scholar and Supervisor's name and signature
  - Four typed copies of model question papers for setting the question papers, and need not mention the name of the scholar and Supervisor's name and signature
  - Panel of examiners/ paper setters/ containing not less than six names with their latest complete official/residential addresses with phone numbers and email address.

**Note:** The title of the paper should be identical in the Syllabus, Model Question Paper and Panel of Paper Setters/ Examiners. A copies of the Admission Proceeding, Joining Report, Title proceedings and Research and Publication Ethics (R&E) 30 hours is compulsory certificate issued by the Dean, (R&D), be enclosed.

In respect of absented/failed candidates, the Research Supervisors are requested to send Xerox copies of the syllabus, model question papers and panel of examiners submitted earlier for taking necessary action for setting the question paper etc., and to avoid last minute confusion.


In case of Inter disciplinary courses, clear mention should be made in the panel about the faculty in which the candidate's having the qualifying Degree and Department in which he/she is doing Research. Both the main guide and co-guide should sign in the panel of paper setter/examiners and syllabus sheet.

Ph.D Candidates Full-Time/Part-Time who have not completed the Pre-Ph.D examination till date, due to various reasons may apply through proper channel for the said examination by paying fine of Rs.10,000/- (Ten Thousands only) apart from the examination fee as a Last Chance.

I am, therefore, to inform that the Research Guides are requested to send the syllabus, Model question paper and panel of Paper setters/examiners etc., pertaining to their candidates directly to the **CONTROLLER OF EXAMINATIONS** on or before: **31.12.2021** under intimation to the Head of the Dept. concerned.
