In continuation to this office Circular 4th cited, it is proposed to consider the option form for promotions to the University teachers who are eligible as on 17.07.2021 under CAS as per Old Regulations (i.e UGC Regulations 2010 and G.O.Ms 38, dated 23-06-2016) for the award of the following AGP / Academic Levels:-

1. Assistant Professor moving from AGP Rs.6000 to 7000 i.e. Academic level 10 to Academic Level 11

2. Assistant Professor moving from AGP Rs.7000 to 8000 i.e. Academic level 11 to Academic Level 12

3. Associate Professor with AGP Rs.9000 i.e. Academic Level 13A

4. Professor Promotion with AGP Rs.10000 i.e. Academic Level 14

5. Professor with AGP 12000 i.e. Academic Level 15

The eligible teachers should invariably exercise their option before 17.07.2021 for considering under old regulations. Therefore, all the Heads of the Department of the University Colleges are requested to forward the applications (in the enclosed Proforma along with option form) from the eligible teachers of their respective Departments for consideration under Career Advancement Scheme as per old regulations.
