With reference to the above, I am by direction to inform that, Full-Time/Part-Time Pre-Ph.D. (Written) Examinations of 2021 will be held during the year 2022. The students **who were admitted during 2019 and 2020 and who have completed one year as Full-Time scholar i.e., upto as on date of issue of circular and Two Years (two summers) as Part-Time scholar i.e. upto 2021,** are eligible to appear for the said examination.


