MEMORANDUM OF UNDERSTANDING between SRI VENKATESWARA UNIVERSITY,TIRUPATI

and

SRI VENKATESWARA VETERINARY UNIVERSITY, TIRUPATI for facilitating COLLABORATIVE PROGRAMMES ON RESEARCH AND EXTENSION

PREAMBLE:

Sri Venkateswara University:

Sri Venkateswara University (SVU) is an autonomous Educational, Research and Development Institution established under the provisions of Andhra Pradesh Act No. 18 of 1957 with its head quarters at Tirupati and various colleges are under its control both in the campus and outside the campus as affiliated colleges. It has the responsibility to undertake research in Basic and allied sciences, extension of such sciences to assist the community and industry of the State by imparting education, research and training. The four constituent Colleges of the University have the responsibility of undertaking activities related to Teaching, Research and Extension in the areas of Biological and Physical Sciences. The colleges are offering Bachelors, Masters and Doctoral degree programmes in various fields. The colleges also have many National and International sponsored research projects under operation.

Sri Venkateswara University, hereinafter called the SVU is represented by its Registrar.

Sri Venkateswara Veterinary University:

Sri Venkateswara Veterinary University (SVVU) is an autonomous Educational, Research and Development Institution established under the provisions of Andhra Pradesh Act No. 18 of 2005 with its head quarters at Tirupati and a number of Livestock Research stations and Colleges under its control. It has the responsibility to undertake research in Veterinary and allied sciences, extension of such sciences to assist the farming community of the State by imparting education and training. The constituent Colleges of the University have the responsibility of undertaking activities related to Teaching, Extension and Research in the areas of Veterinary, Dairy and Fishery Sciences. The colleges are offering Bachelors, Masters and Doctoral degree programmes

in various fields. The colleges also have many National and International sponsored research projects under operation.

Sri Venkateswara Veterinary University, hereinafter called the SVVU is represented by its Registrar.

To foster collaboration, provide opportunity for global experience, and to facilitate advancement of knowledge on the basis of reciprocity, best efforts, mutual benefit, and frequent interaction. a working MoU shall be signed between the heads of the University. The following are the terms of agreement:

Article - I

SVU will facilitate:

SVU is in a position to collaborate with SVVU in all the mentioned areas of interest towards mutual benefits and is willing to specifically facilitate:

- Recognition of the faculty of SVVU as Collaborators for various funding agencies for Collaborative research projects/programmes to be carried out as per the requirement and approved plan of work of the department of Home Science, Food Technology and Food Science Nutrition and Dietetics.
- Recognize the faculty of SVVU as Co-Guides for project works of PG and Ph. D degrees.
- 3. Make available the existing facilities like Laboratories of the Home Science Department at SVU for the students of SVVU for their approved project/research work.
- 4. Prepare joint research projects, which are mutually beneficial to SVU and SVVU and seek funding from outside agencies.
- 5. Sharing of facilities to conduct / organize the International/National conferences/workshops/training programmes.

Article - II

SVVU will facilitate

SVVU is in a position to collaborate with Home Science, SVU in all the mentioned areas of interest towards mutual benefits and is willing to specifically facilitate:

- 1. Recognition of the faculty of SV U as Collaborators for various funding agencies for Collaborative research projects/programmes to be carried out as per the requirement and approved plan of work of various departments- Genetics, Pharmacology, Extension, Pathology, Parasitology, Biochemistry, Microbiology, Poultry, Anatomy, Surgery, Public Health, Dairy technology etc.,
- 2. Recognize the faculty of SVU as Co-Chairman / Members of Advisory Committees for project works of PG and Ph. D degrees.
- 3. Make available the existing facilities like Animal trails, Central Library, Laboratories of various departments, at SVVU for the students for their approved project/research work.
- 4. Undertake staff research based on the location specific problems on mutual agreement.
- 5. Prepare joint research projects, which are mutually beneficial to SVVU and SVU and seek funding from outside agencies.
- 6. Sharing of facilities to conduct / organize the International/National conferences/workshops/training programmes.

Article – III

- 1. This MOU may be supplemented by work plans to be developed jointly, which describe more specifically the activities to be carried out under this cooperation.
- 2. The SVU and SVVU may nominate members of their respective staff to work out the practical details of cooperation between two organizations in general and to ensure proper and effective implementation of this MOU.
- 3. Such details, as agreed upon, will be confirmed by exchange of letters between SVU and SVVU and such approval will form party to this agreement.
- 4. The work plans developed require the approval of both parties for implementation.

SVU can offer:

- 1. Joint proposal of Research-basic/applied.
- 2. Research guidance for PG and Ph.D degree students.
- 3. Sharing of common facilities.

- 1. Exchange of information on Research, Teaching, Learning Materials and other literature relevant to the educational and research programmes.
- 2. Utilization of laboratory facilities and library of College of Dairy Technology, Department of Livestock Products Technology, Microbiology, Animal Nutrition for the course and research work.

Article - IV

This agreement will be effective initially for a period of ten years from the date of signing of this MOU by both the parties and may be renewed further on mutual consent. Either party may terminate the agreement by written notification signed by the appropriate official of the institution indicating the notice. The other party must receive such notice six months prior to the effective termination date.

However, obligations and commitments already contracted for by both the parties shall be honored and continued by both the parties until such commitments are completed. In witness, whereof, the parties hereto caused this instrument to be executed as of the day, month and the year indicated below:
