Article 5: This MOU and any specific programme resulting from it may be modified or amended at any time by mutual consent of the two parties.

Article 6: This MOU comes into effect from the date of it being signed by the representatives of the respective institutions and would remain valid for a period of 5 years and may thereafter be renewed or terminated on mutual consent.

In witness to the above, two identical copies of this MOU in English and two copies in Vietnamese are being signed by the authorized representatives of both institutions, and each party will retain two copies (one in English and one in Vietnamese) of the MOU.
