It is proposed to consider promotions to the University teachers under CAREER ADVANCEMENT SCHEME as per old regulations (i.e., G.O.Ms.No.38, Higher Education (UE) Department, dated 23.06.2016) and new regulations (i.e.,G.O.Ms.No. 14, Higher Education (UE.II) Department, dated 13.02.2019), who are eligible for promotion as on **11.11.2024** for the next higher grade / promotions of the following AGPs/ Academic Levels:-

1. Assistant Professor moving from AGP Rs.6000 to 7000 i.e. **Academic Level 10 to Academic Level 11.**
2. Assistant Professor moving from AGP Rs.7000 to 8000 i.e.**Academic Level 11 to Academic Level 12.**
3. Associate Professor with AGP Rs.9000 i.e.**Academic Level 13A.**
4. Professor Promotion with AGP Rs.10000 i.e.**Academic Level 14.**
5. Professor with AGP 12000 (Stage 6) i.e.**Academic Level 15.**

The eligible teachers who choose old regulations should exercise and submit option forms along with their applications.

Therefore, all the Heads of the Departments of the University Colleges are requested to forward the applications (in the enclosed proforma) from the eligible Assistant Professors / Associate Professors and Professors of their respective Departments as on **11.11.2024** for consideration under Career Advancement Scheme as per the eligibility criteria laid down in the G.O.s cited above.

As such, the criteria for promotions under Career Advancement Scheme now being followed is exclusively in accordance with the old & new regulations stipulated in the G.Os under reference cited above.

The teachers are requested to download the applications from the website www.svuniversity.edu.in and submit their application in **05 sets** (each application and enclosures in paper bound book form) along with all necessary documents.

The filled in applications along with its enclosures of the eligible teachers should reach this office **on or before 30.11.2024**.

The filled in applications received after due date will be strictly rejected.
